These five themes provide a comprehensive understanding of the nuanced ways in which digital education platforms influence skill development, networking, learning flexibility, challenges, and integration into entrepreneurial activities.

5. Discussion

The discussion of findings in this study expands on previous research, providing a comprehensive understanding of the complex relationship between digital education platforms and entrepreneurial ventures.

The current findings are consistent with studies by Vorbach et al. (2019) and Vinogradova et al. (2019), highlighting the robust nature of the impact digital education platforms have on skill development within the educational landscape. The emphasis on diverse skill development is consistent with Vorbach et al.'s work, which emphasizes that digital platforms go beyond imparting technical skills and play an important role in cultivating a broad range of competencies required for entrepreneurial success. These platforms not only serve as repositories of technical knowledge, but also as dynamic environments in which students can develop adaptability, critical thinking, and interpersonal skills—qualities that are increasingly recognized as essential in the entrepreneurial realm. Furthermore, the similarities between Komljenovic's (2021) findings and the current study contribute to a better understanding of the consistent and far-reaching impact of digital education platforms on fostering a globally connected entrepreneurial landscape.

The current study's theme of flexibility and real-time learning is consistent with Udosen and Upula's (2019) findings, emphasizing the importance of adaptability provided by digital education platforms. The ability to access relevant content on demand, as noted in both studies, emphasizes the dynamic nature of entrepreneurship and the practical benefits of using digital education platforms. The findings' consistency emphasizes the critical role of these platforms in meeting the changing demands of the entrepreneurial landscape, by providing entrepreneurs with the tools for continuous and timely learning to navigate challenges and capitalize on new opportunities.

The current study's recognition of challenges, such as platform reliability and information overload, is consistent with the concerns expressed by scholars such as Lall et al. (2023). This agreement emphasizes the importance of recognizing the limitations and addressing quality control issues associated with digital education platforms. Furthermore, Fleaca and Stanciu's (2019) research, which likely addressed challenges within these platforms, aligns with the current study's findings, emphasizing that a nuanced understanding of their impact on entrepreneurial ventures necessitates a thorough examination of potential drawbacks. The consistency with which these challenges are identified across studies contributes to a more holistic and informed perspective, emphasizing the importance of refining digital education platforms to ensure their reliability and effectiveness for entrepreneurs in a variety of contexts.

The current study's observation of insights being integrated into entrepreneurial practices is consistent with the findings of other studies, such as Khasawneh (2024). The study does, however, highlight the challenges associated with reliability and information overload, emphasizing the importance of addressing these issues in order to maximize the impact of digital education platforms on entrepreneurial ventures. This nuanced understanding recognizes the dual nature of these platforms, acknowledging their potential benefits while emphasizing the importance of continuous improvement and quality control measures to ensure their effectiveness.

Finally, the study contributes to a more comprehensive understanding of the role of digital education platforms in shaping entrepreneurs' skills, practices, and success in today's business landscape. In conclusion, this study adds to the ongoing discussion about the symbiotic relationship between digital education platforms and entrepreneurship.
